**VARIATION TO THE PUBLIC SPACES PROTECTION ORDER:  
COUNTY COUNCIL OF THE CITY AND COUNTY OF CARDIFF  
PUBLIC SPACES PROTECTION ORDER (PLASNEWYDD / GROUP 1) 2020**

The County Council of the City and County of Cardiff has varied the COUNTY COUNCIL OF THE CITY AND COUNTY OF CARDIFF PUBLIC SPACES PROTECTION ORDER (PLASNEWYDD / GROUP 1) 2020 which is dated 20 June, 2020 under sections 61, 64 and 72 of the Anti-Social Behaviour, Crime and Policy Act 2014 by extending the restricted area.

The original Order will be superseded by THE COUNTY COUNCIL OF THE CITY AND COUNTY OF CARDIFF PUBLIC SPACES PROTECTION VARIATION ORDER (PLASNEWYDD / GROUP 1) 2021 which will come into force on 23<sup>rd</sup> September, 2021

The variation made to Schedule 2 of the original Order is to extend the "Restricted Area" as follows:

PLA 57(a)	Alleyway to the rear of 1-47 Partridge Road, 1-32 Willow Court and <b>1-3 Elm Street, Roath, Cardiff</b>	At all times for the duration of the Order
